Conversion of shares

According to SCA's articles of association, owners of Class A shares have the right to have such shares converted to Class B shares. Conversion reduces the total number of votes in the company. When such a conversion has occurred, the company is obligated by law to disclose any such changes in this manner.

In November, at the request of shareholders 17,520,373 Class A shares were converted to Class B shares. The total number of votes in the company thereafter amounts to 1,312,086,375.

The total number of registered shares in the company amounts to 705,110,094 of which 67,441,809 are Class A shares and 637,668,285 are Class B shares.
